Whereas subscriber is engaged as M/s. MNR medical College and hospital established by MNR Educational Trust and requested Shaam Internet Service to provided internet Connectivity on a point to point basis i.e. from Shaam internet services /POP to the premises of MNR Educational Trust Sangareddy.


The parties now being desirous of reducing this agreement in writing have entered in to this agreement with the manner herein after appearing:

1. Subscriber shall pay an amount of Rs 33,898/- (Rupees Thirty Three Thousand Eight Hundred and Ninety Eight only) per month plus applicable GST@18% at present towards the Charges for 1000 Mbps (1:1) Internet bandwidth services. Subscriber shall make payments Monthly basis after completion of each month w.e.f 1st March, 2024.
2. Hardware required for connectivity at subscriber end will be taken care by subscriber and maintenance of the said connectivity shall be taken care by M/s Shaam Internet Services on actual.
3. Shaam Internet Services shall provide 6 public IP addresses for 1000 Mbps (1:1) dedicated Internet connectivity to the Subscriber.
4. Shaam Internet Services shall ensure 97.9% up time. Subscriber assumes the responsibility of going for bandwidth owing to the criticality of his business operations.
5. Subscribers shall use the internet connectivity at the premises specified at the time of installation to Shaam Internet Services, However in case of any possible shift/change of address, subscriber shall intimate the same to shaam internet services in writing wherein shaam internet service shall provide internet connectivity to the said premises after inspection of the same.
6. Shaam Internet Services will provide backup line, high availability of internet connectivity to the subscriber.
7. Shaam internet services shall ensure immediate response on subscriber queries but will not be responsible for subscribers internal LAN Connectivity issues.
8. If required the up gradation and down gradation of existing bandwidth will be permitted to change during the contract period but the cost per bandwidth will be charged on prorata basis, on the request sent to the service provider through subscriber's official email or official written communication.
9. This contract is valid from 01.03.2024 to 31.12.2025, and shall be renewed at mutual consent at the end of the contract period.
