

- vi. Injury to body, causing hurt or grievous hurt;
- x. Assault as well as sexual offences or unnatural offences;
- xi. Extortion;

xvii. Physical or psychological humiliation;

#### Annexure - I

The following method was exercised by the Principal office:

- Principal, came to know about the complaint on 21.09.2021, in the midnight at about 12.11 am on telephonic information from anti-ragging helpline
- He rushed to the hostel on the same night and enquired about the culprits, and made phone calls to the parents of the culprits and summoned them on next day morning to his office
- The Anti-Ragging Committee is revised as some members left the college in the recent past.
- An office order was drafted by the Principal to proceed for investigation

The following procedure is adopted by Anti-Ragging Committee:

- Visited the hostel and mess (alleged scene of offence)
- Visited the rooms of alleged culprits and the Junior batch wing
- Scrutinized the register meant for anti-ragging squad visits
- Called the alleged culprits along with their parents and collected their statements
- Suggested the Principal to keep the alleged culprits under suspension and made them
  to vacate the hostel immediately, so as to conduct unbiased investigation and to
  strengthen the morals of the suspected victim so as to make him feel safe
- Statements are collected from the all the juniors residing in the hostel
- Statements from members of anti-ragging squad are collected
- Statements of supervisor of the hostel and security personnel are taken
- Informal oral enquiry made in the junior's classroom and collected the opinions about any methods of ragging, even from day scholars
- Ultimately, the victim (junior) is identified, counselled and took him in to confidence and made him to understand that authorities are with him. His identity is not disclosed to anybody in the institution.
- The academic record of the seniors is also considered
- Photographs are collected wherever possible without annoying the students
- All details are summed up and considered with compassion
- The prepared report is submitted in the Principal's office for onward transmission to the concerned authorities.

## Annexure - II

- There was an alleged ragging complaint lodged in Anti-ragging help line from the student of First year i.e. 2020\_21 batch with <u>ARCC/TS-6787</u>
- It is observed by us that, First year students are residing in the ground floor of the boy's hostel and there is an iron grill to that wing, which will be under lock and its key is under warden's custody from 9.00 pm to 6.00 am, wherein there will not be any access to senior students to junior batch. The juniors are escorted by the security to mess and Medical college and are not left all alone at any point of time
- There are identified faculty, who are residing in the campus including the Principal under the responsibility as anti-ragging squad, who make regular rounds to both Girl's and Boy's hostels in odd hours.
- The details of the Anti-ragging committee and anti-ragging squad with their contact numbers are made available at all prominent places in hostels, medical college and hospital.
- After detail enquiry in to the incidence, it is found that, out of three alleged culprits, Mr. Sucharith reddy joined the hostel on 20.09.2021 afternoon after coming from lockdown.
- The other two alleged culprits (Mr. Arun and Mr. Akhilesh) joined two weeks earlier in to the hostel.
- It is found that, one of the students of First year (2020\_21 batch) was called by his senior (Mr. Arun, student of 2019\_20 batch)) at the mess and was asked to bring water for him, as the victim was moving towards water cooler and it was witnessed by two other students (both are from Junior batch). The victim got annoyed and informed his parents, in-turn his parents made the complaint to the anti-ragging helpline. The victim is taken in to confidence and given moral courage. (Names of the victim and witnesses are not disclosed, as it is suggested by the Anti-Ragging helpline)
- It appears that, the complaint made is frivolous, and made under rage by the victim and his parents, as there is no scope for the seniors and juniors to mix up in the hostel to make the juniors dance or sit-ups.
- The college was reopened on 03.09.2021 after lockdown period and there are no project works given to the senior batch, since the physical classes have started recently. Hence forcing the juniors to complete the project works of seniors is not possible.
- However, to curtail the menace of ragging, the alleged culprits should be punished to deter others from indulging even in such trivial activities.
