I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 26.06.2018 considered the assessment Report (10.05.2018) on the standard of examination and other teaching facilities available at MNR Medical College, Sangareddy for purpose of Recognition of MD/MS(Anatomy) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh. The Committee decided as under:-

"The Postgraduate Medical Education Committee considered the assessment Report (10.05.2018) and decided to recommend to the Central Government that MD/MS(Anatomy) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at MNR Medical College, Sangareddy be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
